Your questions answered



Who sets my payment plan fees?

Your fees are set by your registered dental practice and can then be reviewed once a year. Your dentist chooses a fee category for you, with a monthly cost that will cover your individual dental needs.

Who is my contract with?

Your Denplan payment plan contract is between you and your registered dentist. We administer your plan by collecting your payments and passing the majority on to your dentist.

Your plan covers the routine check-ups and general dental care you receive from your registered dentist. Referrals to another dentist or specialist for dental treatment aren't included in your plan. If you have any queries about your cover, speak to your dental practice team.

What do I do in a dental emergency?

If you're within 40 miles of your dental practice, call them and seek help from your registered dentist.

If you're more than 40 miles away from your dental practice and you have Denplan Supplementary Insurance, call 0800 844 999, or +44 1962 844 999 if you're abroad, and one of our experts will help you.

If you're more than 40 miles away from your dental practice and you do not have Denplan Supplementary Insurance you can call the NHS on 111 for assistance.

I'm moving house and need to find a new dentist that offers your plans

We're delighted you'd like to stay with us! There are three simple steps to change your dentist and keep the benefits of your payment plan:

1. Visit your current dentist for a final check-up
2. Let our Patient Support Team know you're leaving that dentist

Giving you the choice!

A part of your monthly fee has always gone towards ensuring you're protected by Denplan Supplementary Insurance. We're proud that you can come to us to get the help you need if you ever suffer from a dental emergency or injury.

Denplan Supplementary Insurance used to be a mandatory part of your payment plan. Now, due to the Insurance Distribution Directive legislation that came into force on the 1st October 2018, you have the choice to remove this insurance from your plan.

I like my insurance and I want to keep it!

That's great, and really easy to do! Keeping your insurance requires no action at all, if we don't hear from you we'll keep it going automatically.

What will removing my Denplan Supplementary Insurance do?

Every patient who has this insurance removed from their plan will lose the protection of this insurance. A full list of benefits can be found in the insurance policy document provided. The plan's monthly fee will then reduce by a maximum of 60p.

What if I have Denplan Implant Upgrade Cover?

Cancelling your Denplan Supplementary Insurance will also cancel your Denplan Implant Upgrade Cover.

Do I have to decide now?

No. You can submit a request to remove your insurance cover now, later or any time you want.

How do I remove my insurance?

The person who pays for your plan can remove your insurance by calling 0330 6780 988 or visiting www.denplan.co.uk/MyInsurance to do it online. **Please Note:** You'll need your paygroup number to remove the insurance.





Teeth times

Following a regular oral health routine is an essential part of achieving and maintaining good oral health. Brushing and cleaning between our teeth are everyday activities that we all do, but did you know that there are optimum times and ways to do these to get maximum benefits for our oral health? Henry Clover, Chief Dental Officer at Simplyhealth Professionals shares his top tips.

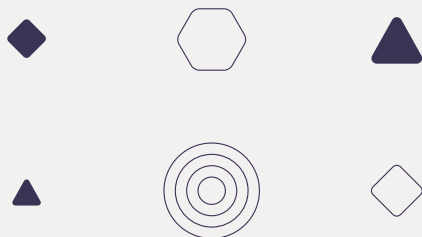


The best time to brush your teeth

“It’s fairly well known that everyone should be brushing their teeth for two minutes, twice a day,” says Henry. “This should be the last thing you do before you go to sleep, and on at least one other occasion during the day.”

“What many people are unaware of is that your tooth enamel is softer after it’s been exposed to acidic or sugary food and drink. If you brush your teeth immediately after eating or drinking something acidic, you could be scrubbing away some of the surface tooth enamel. Your saliva helps your tooth enamel to re-harden, which takes about an hour.

“It’s best to brush your teeth before any acidic meals or snacks, or wait at least an hour after eating or drinking before you brush.”

The survey was carried out online. The figures have been weighted and are representative of all UK adults (aged 18+).



The best time to use mouthwash

“Mouthwash is great at refreshing your mouth after a meal or partway through the day – use it for the same reasons that you use chewing gum,” advises Henry.

“People often finish their brushing routine with a rinse of mouthwash, but this really isn’t the best time, unless otherwise advised by your dentist. After you finish brushing, you should spit the toothpaste out and avoid rinsing your mouth, even with mouthwash. You want to ensure that you keep your teeth coated in toothpaste residue so that the fluoride protects your teeth for as long as possible.

“Most toothpastes contain optimum fluoride levels of 1350 - 1500ppm (parts per million) whereas most mouthwashes only contain around 200 - 500ppm or none at all. If you rinse with mouthwash, you’ll likely be washing away the higher level of protective fluoride.”



The best time to snack

“Tooth enamel is softer after eating and drinking because the bacteria in our mouths feed on traces of food/drink and produce acids which can attack teeth,” says Henry. “Your teeth can withstand around five ‘acid attacks’ a day before it becomes damaged. If you’re having three meals a day, it’s best to limit any snacks to twice a day. Try to opt for low sugar, low calorie snacks such as vegetables or fresh fruit.”



The best time to floss

“As long as you’re cleaning between your teeth thoroughly at least once a day, it doesn’t actually matter too much what time of the day you floss,” says Henry. “Over a third of UK adults (37%) admit to never flossing*, so choosing the most convenient time for you will make you more likely to do it.”




